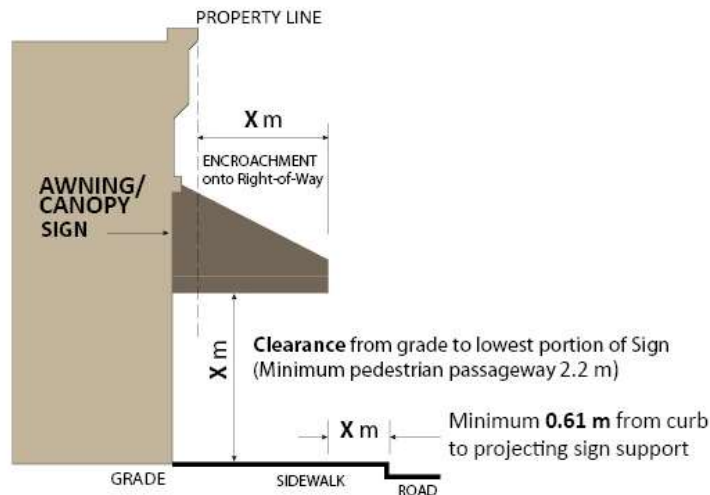

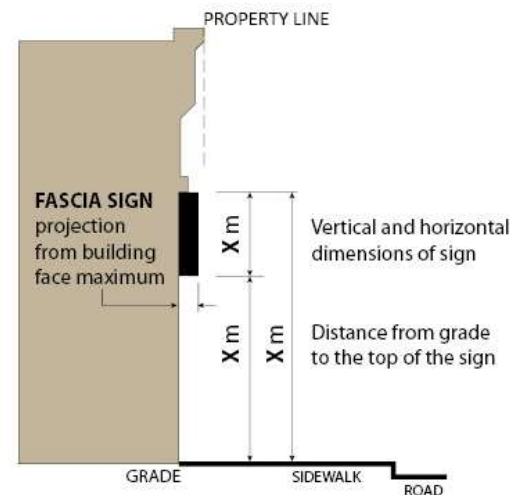

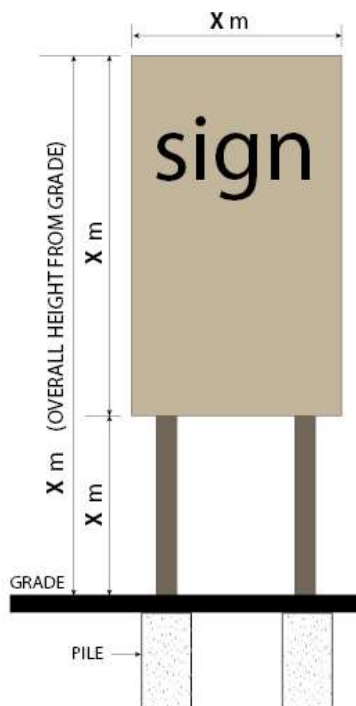
Projecting Sign



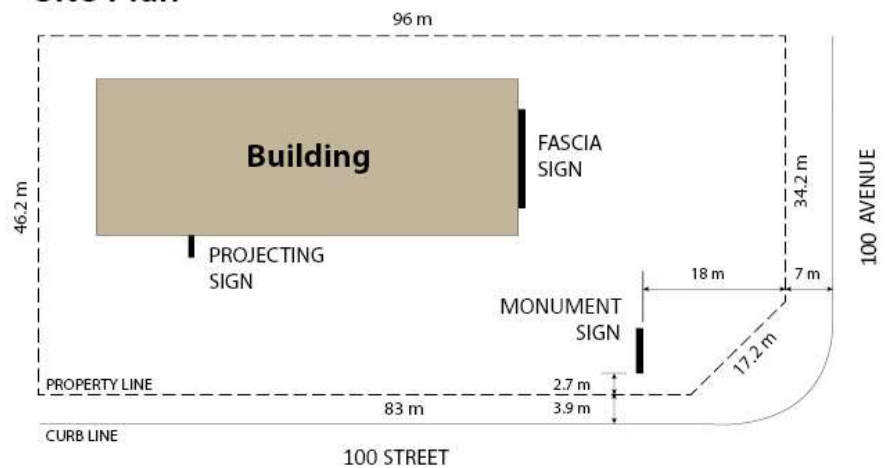
Fascia Sign
