



UTILITIES SERVICE ALTERNATE INVOICE ALLOCATION REQUEST

'Waterworks Regulation Bylaw No. 3204, 2019'

Section 45.1:

In the case of a duplex that contains two separate legal parcels serviced by a single meter or a bare land strata with four or less legal parcels, which otherwise would not collect strata fees, the Collector will calculate the total billing charges for the parcels and issue a bill to each parcel owner for an equal proportionate share of the total bill, except that the Collector may alter the allocation of the bill with the consent of the owners of all the parcels.
